- 1. Only those individuals who believe in the principles of Hinduism are eligible to become members. The membership eligibility and dues are subject to the provisions of the By-Laws of Sacramento Laxmi Narayan Temple. The current lump sum dues are as follows:

 Life Membership \$ 1,000.00; Regular Membership \$ 120 per year
- 2. Life Membership dues can be paid in four (Four) equal installments of \$300 each. Payment default of the monthly installments for the Life Membership of more than one month will result in the cancellation of Life Membership. The membership status will be automatically changed to that of a Regular Member and dues paid will be credited towards this membership.
- 3. Regular Membership should be paid in a lump sum of \$120 due during January of each year. However, members who join Sacramento Laxmi Narayan Temple during middle of the year will pay the membership dues as follows:

- 4. Membership in Sacramento Laxmi Narayan Temple is not a right but a privilege. All membership applications have to be reviewed and voted by the Board of Trustees.
- 5. Every member is expected to observe the decorum and the religious sanctity of the temple.
- 6. The By-Laws can be obtained from the Secretary of Sacramento Laxmi Narayan Temple by requesting a copy in writing and paying a request processing and photocopying fee of \$ 5.00
- 7. A member whose past membership dues exceed dues for six months loses the right to have his membership reinstated to active status (by paying up past dues) and must make a fresh Membership application to start the membership process all over again. The administration will attempt to notify any member whose dues exceed 3 months dues by ordinary U.S. Mail. But it is the responsibility of the member to keep payments current and prevent membership from becoming inactive or lapsing.
